AFFIDAVIT OF MEGAN PRIESTMAN

I, MEGAN PRIESTMAN, of the City of Calgary, in the Province of Alberta,
MAKE OATH AND SAY:

1. I am a paralegal at the Justice Centre for Constitutional Freedoms. I have personal knowledge of the facts and matters hereinafter deposed to by me save and except where same are stated to be based upon information and belief, in which case I verily believe them to be true.
2. Attached to this affidavit as **Exhibit "A"** are the answers to the undertakings of the Respondent from the cross examination of Ward Keith. In response to an undertaking to provide the identity of the individual who submitted the single complaint received by the Respondent regarding Mr. Troller's license plate, "ASIMIL8" (the "Plate"), the Respondent identified a "MaryAnn Wilhelm" as the complainant.

3. Attached to this affidavit as **Exhibit “B”** is the complaint from Ms. Wilhelm, submitted to the Respondent via email on April 25, 2017 (the “Complaint”). In the complaint, Ms. Wilhelm identified herself as being the “Outreach Director for the NDP Aboriginal Commission.” She also identified herself as a resident of Owen Sound, which is located in Ontario.
4. Attached as **Exhibit “C”** is Ms. Wilhelm’s LinkedIn profile, in which she details her positions with the NDP Aboriginal Commission.
5. Attached to this Affidavit as **Exhibit “D”** is Ms. Wilhelm’s Facebook profile. On April 22, 2017, Ms. Wilhelm posted on her Facebook account a photograph of the Plate (the “Complaint Facebook Post”, attached this Affidavit as **Exhibit “E”**). Included in the Complaint Facebook Post, is the following text, which is identical to most of the text of the Complaint she submitted to the Respondent on April 25:

I am MaryAnn Wilhelm, while I am the Outreach Director for the NDP Aboriginal Commission, I am calling on behalf of myself, and of those who've been shocked and offended by what is being driven around in Winnipeg Manitoba.

First, I want to mention that I am aware that a man lost his vanity plate in the east coast of Canada, his vanity plate said GRABHER. While I question the pulling of ones own name, I understand the issues around that plate. I have no questions however when it comes this vanity plate roaming the streets of a highly populated indigenous city with the ID of ASIMIL8.

In an era of TRC, where we, Canadians, and Indigenous are working to reset relations, I found this vanity plate to be appalling to this country.

How did this even manage to pass the desk of those who analyze and approve plates is beyond my imagination unless they simply thought that it was acceptable to do so.

If that was the case, then departments who approve these plates should be required to take Indigenous cultural training to ensure offensive plates like ASILIM8 don't end up on Canadian roads.

I am requesting an investigation and an apology over the issuance of the plates, and request training take place at these agencies that process vanity plates.

6. Ms. Wilhelm further posted the Complaint Facebook Post on the Facebook page of the Aboriginal Congress of Alberta Association on the same day, April 22. (attached to this affidavit as **Exhibit "F"**).
7. Ms. Wilhelm also "tweeted" a link to the Complaint Facebook Post, also on April 22 (attached to this affidavit as **Exhibit "G"**). In this "tweet", Ms. Wilhelm "tagged" the Winnipeg Free Press, thereby alerting the media. Attached to this affidavit as **Exhibit "H"** is Ms. Wilhelm's Twitter profile, where she indicates her association with the NDP Aboriginal Commission.
8. Ms. Wilhelm commented several times on the Complaint Facebook Post. In one comment she requests individuals to call the Respondent to complain about the Plate. In another comment, she states that she "sent"


her Complaint to CTV News Winnipeg.

9. On April 25, 2017, the same day Ms. Wilhelm's Complaint was submitted to the Respondent, Ms. Wilhelm posted comments on her Facebook account, which she titled "News Flash" (attached to this affidavit as **Exhibit "I"**). In this post, Ms. Wilhelm commented on a discussion she had with Carla Hocken, Manitoba Registrar of Motor Vehicles at the time, when Ms. Hocken phoned Ms. Wilhelm earlier that same day regarding the Complaint.
10. The Plate is not the first Manitoba license plate Ms. Wilhelm has complained about. On November 4, 2014, Ms. Wilhelm posted on her Facebook page a post containing what appeared to be a picture of a Manitoba license plate, "IH8NDNS" (attached to this affidavit as **Exhibit "J"**). The same day, she "tweeted" a link to the Facebook post, "tagging" the Manitoba Government (attached to this affidavit as **Exhibit "K"**). The Manitoba Government "reply tweeted" to Ms. Wilhelm that the "IH8NDNS" license plate had "not been issued by MPI" and was an "altered" image.
11. Prior to submitting the Complaint to the Respondent on April 25, Ms. Wilhelm was made aware that the Plate was a reference to Star Trek, specifically the aliens known as "the Borg". The picture of the Plate that Ms. Wilhelm posted shows the border around the Plate that reads "WE ARE THE BORG / RESISTANCE IS FUTILE". Further, several Facebook users commenting on the Complaint Facebook Post informed Ms. Wilhelm that the Plate was likely a reference to Star Trek. Ms. Wilhelm

acknowledged that she read these comments, prior to submitting the Complaint to the Respondent on April 25, by responding to them.

12. I affirm this affidavit bona fide, and for no improper purpose.

**ANSWERS TO UNDERTAKINGS OF THE RESPONDENT
FROM THE EXAMINATION FOR DISCOVERY OF WARD KEITH**

1. Undertaking: Inquire if received a package, and if so, produce it.
Answer: No package was received.

2. Undertaking: Advise if application was on the approval list or questionable list and produce the applicable list.
Answer: At the time, no concerns were identified with any of the slogans so no questionable list was produced. Attached to these answers as **Schedule "A"** is an email dated July 3, 2015 regarding PLP slogans to be approved. Attached to these answers as **Schedule "B"** is a spreadsheet of the PLP slogans to be approved for the period June 29-July 3, 2015.

The "list" was for approved slogans. Questionable slogans, those with concerns identified, were provided in an email.

3. Undertaking: Advise of title and position of committee members at the time.
- Answer: The committee consisted of:
- John Hallonquist - Executive Director, Service Centre Operations
Charlene Figueiredo - Business Relationship Manager
Brian Smiley - Media Relations Coordinator
Charray Dutka - Senior Policy Analyst, KMS
Margaret Kobylinski - Assistant Manager, Licensing Services
4. Undertaking: Advise if any committee members had received any training in regards to the Charter.
- Answer: No training regarding the Charter was provided to the committee members.
5. Undertaking: Advise if MPI maintains a list of all prohibited PLP slogans.
- Answer: MPI maintains a list of all prohibited PLP slogans.
6. Undertaking: Provide list of prohibited PLP slogans when Mr. Keith became Registrar, when Ms. Hocken became Registrar, and as it is today, if possible.
- Answer: Attached to these answers as **Schedule "C"** is a current list of the prohibited PLP slogans. The list is not maintained in a way that MPI can determine when certain slogans were added to the list. All slogans that were entered prior to July 2010 have an effective date of 1996. There is no way to determine if the applicable slogans were entered before or after 2006, when Mr. Keith became the Registrar of Motor Vehicles.
7. Undertaking: Advise if there is any other criteria that the Registrar uses to determine if the standard is met.
- Answer: There are no other criteria that the Registrar uses to determine if the standard is met.

8. Undertaking: Advise if MPI has ever received any complaints regarding the "Support Our Troops" specialty licence plates.
- Answer: No complaints regarding the "Support Our Troops" plates have been received by the PLP team or MPI's Customer Relations Office.
9. Undertaking: Provide identity of complainant.
- Answer: MaryAnn Wilhelm.
10. Undertaking: Produce follow-up e-mail received from the complainant.
- Answer: Attached to these answers as **Schedule "D"** is a copy of Ms. Wilhelm's email of April 25, 2017.
11. Undertaking: Produce interoffice e-mails from April 24, 2017 through to April 27, 2017.
- Answer: Attached to these answers as **Schedule "E"** are copies of the interoffice emails regarding this matter, sent between April 24, 2017 through April 27, 2017.
12. Undertaking: Determine if the process for recalling PLPs is written and, if so, produce it.
- Answer: Attached to these answers as **Schedule "F"** is a copy of PLP surrender process.
13. Undertaking: Advise in current role if any other PLPs were recalled.
- Answer: Mr. Keith was aware of recalls involving the following plates: NOTTS C, WHITEY7 & GDISLUV.

14. Undertaking: Produce the procedure for handling complaints if it's not included in the procedure for recall and if it's written.

Answer: The procedure for handling complaints specific to PLPs has not been documented.

If that was the case, then departments who approve these plates should be required to take Indigenous cultural training to ensure offensive plates like ASILIM8 don't end up on Canadian roads.

I am requesting an investigation and a public apology (it's moving across the internet) over the issuance of the plates, and request training take place at these agencies that process vanity plates.

Please keep me updated as to the process that is being done to remove these plates and what is being done to train staff to be more sensitive to the Indigenous population.

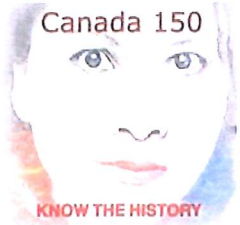

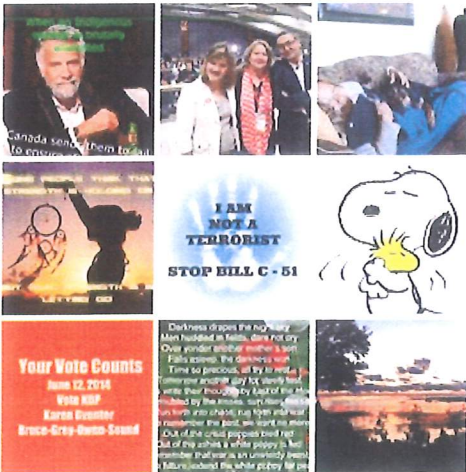

NEWS FLASH:

I am happy to announce to viewers and supporters that I received a phone call from Carla Hocken, Registrar of Motor Vehicles In Manitoba.

She's indicated that she is mandated with the power to immediately pull plates. Carla was as equally surprised as to how this plate could have been approved and assures that there will be deeper investigation.

Carla has indicated that the owner has already been contacted and by tomorrow these plates will be in their hands.

I spoke to the need of a thorough investigation as to how this got pass their usual scrutiny and to commit to further training.

In addition, Carla affirms that in the work of Truth and Reconciliation Canada, the departments were provided with cultural training back in 2016. She's added that they are not sure if it's completely finished and added, she'll be investigating that as well. Carla was apologetic and stated that they are firmly committed to inclusion.

I let her know that I reviewed previous plate applications that didn't make it past first stage, some of which I didn't understand, so I was quite surprised that ASIMUL8 got through.

I encouraged Carla to make a public announcement to denounce the plates. My hopes are if they haven't already, hire Indigenous staff in their department that will be better attuned to stop something like ASIMIL8 from happening again.

Thank you Carla, for your prompt and effective work and to my Indigenous friend for trusting in my ability to deal with this failure.
