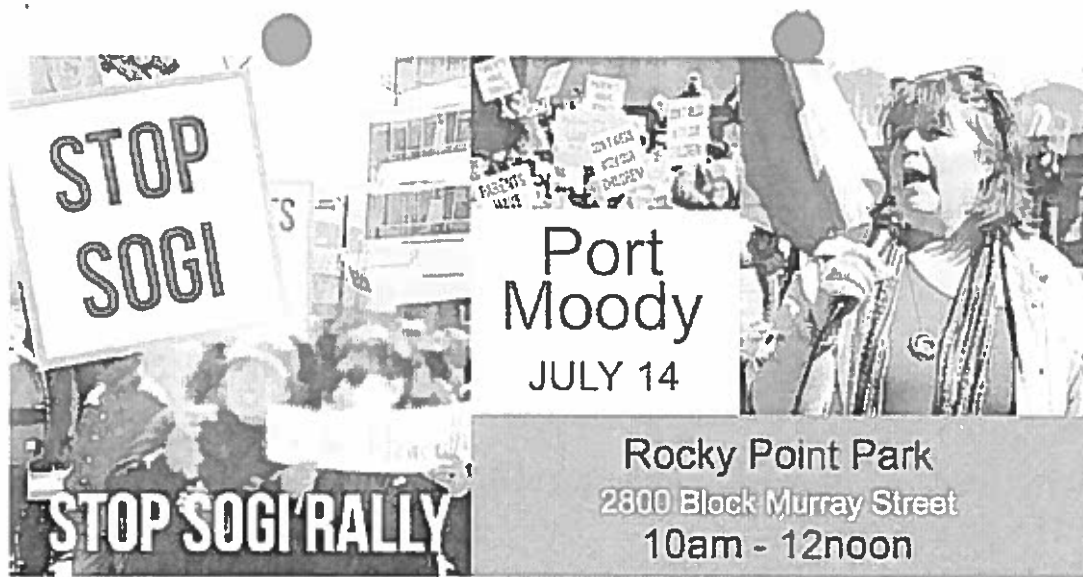
Hi folks – just an FYI on this:

‘Stop SOGI’ rallies will continue to be held!



The Rally to Unite Parents for Respectful and Quality education is on! An attempt by sex activists to cancel the Rally is a bust! Organizers, speakers and many of those expected to attend say they are prepared to be fined, if need be.

The rally scheduled for tomorrow at Rocky Point Park in Port Moody was cancelled by the city and the permit issued weeks ago revoked late yesterday after complaints were made to the parks manager about the Culture Guard event.

"We will no longer tolerate the bully tactics of sex activists," Simpson states. "All children deserve to be protected, and the Charter-protected rights of all people to assemble and freely speak in the public square will be exercised."

In a jointly written notice of cancellation threats of by-law enforcement and arrest were made by Jim LaCroix, Port Moody Recreation Manager, and Kate Zanon, GM for Community Services.

They state:

"If you still choose to go to Rocky Point Park this Saturday, you will be in contravention of Parks and Facilities Bylaw BL2894-C which would result in a fine and a request to leave the park. If the request from the Bylaw Officer is not complied with, assistance from the Port Moody Police will follow. All City property would not be appropriate for this use, therefore choosing another public space in Port Moody would result in the same bylaw contravention."

Kari Simpson, Executive Director for CultureGuard says she's tired of the, threats, lies, vicious name-calling, and empty-minded assertions of sex-activists, like Minister of Education Rob Fleming, who wants to brainwash children by the abusive and coercive tactics embedded in the SOGI agenda. "We will not be silenced. We will protect all children, and the rights of all people—not just the small, but loud and privileged power lobby of sex activists" says Kari Simpson, Executive Director for CultureGuard.

It's anticipated that more than 200 parents and other education stakeholders will unite to inform other parents about the dangers of the SOGI agenda that is now gripping BC schools. More rallies are

being planned.

"Children attending publicly-funded schools are not convenient pawns to be used and abused by a political agenda," she asserts.

"SOGI 123 is dangerous," she said. "The momentum is building to STOP SOGI; it's galvanizing informed education stakeholders across the province in massive numbers. SOGI is NOT about inclusivity or facilitating the reduction of bullying in the schools."

SOGI indoctrination is illegal, Simpson points out. The Ministry of Education and local school boards are required by law to consult and engage parents. The Statement Of Education Policy Order (Mandate For The School System) in BC requires the involvement of parents.

The rights of parents mandated in the Order in Council Policy 280/89 states:

Parents have the right and responsibility to participate in the process of determining the educational goals, policies and services provided for their children. They have a primary responsibility to ensure that children are provided with the healthy and supportive environment necessary for learning. They have a responsibility to help shape and support the goals of the school system and to share in the tasks of educating their young.

Indoctrinating children with SOGI-related sex activist propaganda and 'gender fluidity' lunacy has never been an educational goal, policy or service that parents were consulted on or involved with.

Simpson states: "SOGI will be stopped. All children will be protected from abuse by sex activists driven unions (BCTF, CUPE), politicians and teachers who violate their limited role in the lives of children. Parental rights will be respected and protected."

The General Manager of Community Services and I just learned of your booking for this Saturday at Rocky Point Park.
