#### Request

You requested the following records (the "Request"):

- Any records containing analysis, information and recommendations to the Provincial Health Officer, Bonnie Henry, pertaining, directly or indirectly, or via inference in the ordinary course, to the re-introduction of the prohibition of inperson worship services via verbal announcement December 3, 2020, confirmed by her order of December 4, 2020.
- 2. Any records containing analysis, information and recommendations to the Provincial Health Officer, Bonnie Henry, pertaining, directly or indirectly, or via inference in the ordinary course, to the continued permission to hold low-intensity indoor exercise and support group meetings as announced December 3, 2020, confirmed by her order of December 4, 2020.
- 3. Any records containing analysis, information and recommendations to senior staff of the BCCDC and PHSA pertaining [...] to the permission to hold low-intensity indoor exercise and support group meetings as announced December 3, 2020 and confirmed by her order of December 4, 2020, including but not limited to:
  - a. Dr. Réka Gustafson, Vice President, Public Health and Wellness and Deputy Provincial Health Officer
  - b. Noorjean Hassam, Chief Operating & Professional Practice Officer

#### Response

Please find enclosed a release of records, consisting of 1 page, provided to our office by the BC Centre for Disease Control.

These records are disclosed to you in their entirety.

## Section 25 (Information must be disclosed if in the public interest)

In the Request you stated that:

"PHSA and BCCDC, under Section 25 of the Freedom of Information and Protection of Privacy Act, have a positive obligation to disclose information that is "in the public interest" and is "about a risk of significant harm to the environment or the health or safety of the public." The circumstances of the pandemic clearly meet the public interest test to mandate proactive disclosure. The subject matter of this request directly pertains to information immediately relevant to a risk of significant harm to the public and the public's ability to make their own assessment of risk mitigation choices. I would further argue that the information requested regarding analysis, information and recommendations leading to the imposition of severe restrictions on the Charter rights of every citizen of the Province is itself of such grave public interest, and of such importance to each citizens' ability to assess their personal risk and options, that is would add to the existing information already released in a material and compelling manner. For this reason, although I make this request for information formally under the Act, it is my belief that these public records should be already be released and that the failure of the PHSA and the BCCDC to do so is in direct contravention of Section 25 of the Act."

The Provincial Health Services Authority ("PHSA") recognizes Covid-19 presents a risk of significant harm to the health of the public and that section 25 of the Act requires that, as a public body, we provide to the public information that discloses the existence of the risk, describes the nature of the risk and the nature and extent of any anticipated harm, and which allows the public to take the necessary action to mitigate the risk or avoid the harm (see Re Office of the Premier and Executive council operations and Ministry of Skills Development and Labour, 2002 CanLII 42472 (BC IPC), at paras 45-46).

In the circumstances of the Request, however, PHSA takes the position that this obligation has been satisfied by the disclosures which have been made on an ongoing basis by PHSA as well as the other public bodies responsible for managing this public health crisis. As Commissioner McEvoy recently held in *Re British Columbia (Health)* (2020 BCIPC 66 (CanLII)), a decision on the section 25 obligation in the context of the Novel Coronavirus:

There is [...] a great deal of publicly available information about the nature of the risk, including information about the infectiousness of the virus and how it is transmitted. The available information enables the public, at the government, community, public agency and individual levels, to understand what action is necessary to avoid or reduce the risk. For instance, the information includes a great deal of guidance on steps that governments, communities, public agencies and individuals can and should take to avoid or reduce the risk. (at para 95)

PHSA takes the position that the reasoning expounded by the Commissioner in this decision is equally applicable to the information at issue in the present request. In our view, section 25 of the Act does not require the proactive disclosure of the information requested in the Request because these requirements have been met through the enormous volume of information which is already publically available—and which is continuously being updated—on, *inter alia*, the transmissibility of Covid-19 in in-door

settings in order to enable the people of BC to mitigate the risk of contracting the novel coronavirus.

Note: The reported outbreak in a dance school in FE occurred after the data extract for this analysis. As of Nov 9, it includes 44 cases and all cases are FHA residents. All cases are reported between Oct 25 and Nov 8 (Phase 3b). Cases are between 7 and 44 years of age, 36 (81.8%) are between the ages of 10-19 years.
