

## Freedom and Choice: Values worth fighting for

Our grandparents fought and died so that we could live free and secure in our own land. The Canadian Charter of Rights and Freedoms protects the right to move and travel freely; gather and assemble peacefully; associate freely; practice one's faith; honour one's conscience; and have governments respect individuals' basic right to bodily autonomy. Vaccine mandates and "passports" have been imposed on Canadians across the country and in every sector - employment, education, religion, travel, and leisure. Did we fully consider the costs? Are mandatory vaccines ethical?




## A violation of the Charter

Vaccine passports directly violate our privacy and mobility rights, our right to bodily autonomy, and our freedom of association and assembly. And for what benefit? It is clear from the examples of Israel, Iceland, and other countries that high vaccination rates do not stop virus spread. An Israeli study with over 700,000 participants found that "fully vaccinated" persons had anywhere from 6 to 13 times as much risk of "breakthrough" infections and hospitalization compared to unvaccinated people who had recovered from Covid and had natural immunity. Around the world, both vaccinated and unvaccinated can catch and spread Covid.




## A violation of medical ethics

Mandatory vaccines violate a core principle of medical ethics: free and informed consent. Are we free to choose when threatened with losing our jobs, or denied the right to travel or to attend university? What about the risk of severe adverse reactions to these new mRNA vaccines, such as blood clots and myocarditis, and sometimes death? Every individual has the right to weigh the risk of Covid against the risks of the mRNA vaccines and make her/his own medical decision.



## Risks versus benefits

The Justice Centre advocates for every person's right to medical privacy and voluntary choices. As the Canadian Medical Protective Association put it: "Every human being of adult years and of sound mind has the right to determine what shall be done with his or her own body." Government



data and statistics tell us that Covid has not proven to be the deadly and dangerous threat that government and the media portray it as. Covid is not the Spanish flu of 1918, when 1 Canadian in 148 died. Instead, the survival rate for Covid for people under 60 with no co-morbidities is 99.95%. The government's own numbers reveal that Covid is similar to the flu outbreaks of 1957 and 1968. For the majority of Canadians, there is a greater risk of dying from a car accident than from dying from Covid.

## Safe and effective?

Vaccines utilizing mRNA technology are new and have not been subjected to long-term safety testing in humans. During the first eight months that the Covid shots were available to the public, they caused more than 14,000 deaths in the United States alone, according to the Vaccine Adverse Effects Reporting System (VAERS). This is more deaths than all deaths from all vaccines combined, over a period of 31 years. If the Covid shots are truly effective, then why do the vaccinated need to be "protected" from being in the same room with unvaccinated Canadians?

## The need to stand up now

Countless hardworking Canadians have lost their livelihoods because of the mandates. Unvaccinated patients have been denied life-saving organ donations. Families have been separated and denied the ability to travel by airplane to see one another. Canadians have been denied entry into churches and grocery stores. Do you want to live in a country that forces people to take an experimental drug or treatment in order to participate in society and keep their job? Is it OK to segregate and discriminate against one group of citizens because they exercised their fundamental right to make a personal medical choice?
