A step-by-step guide

STEP 1:

Complete the Securities Transfer Form on the next page. (Your investment advisor or broker can provide you with the information you need.)

STEP 2:

Email the completed Securities Transfer Form to our giving team at **giving@jccf.ca**. We need this information in order to issue you a charitable giving tax receipt.

STEP 3:

Email the completed Securities Transfer Form to your **broker or investment advisor**. Your advisor or broker will initiate the transfer.
